Our Commitment

- We provide culturally safe and inclusive services, including for Aboriginal and Torres Strait Islander children, children with disability, and children from culturally and linguistically diverse backgrounds.

5. Staff and Contractors are Suitable and Supported

- We apply robust recruitment, screening, and supervision practices.
- All staff and contractors receive ongoing training in child safety, mandatory reporting, and professional boundaries.

6. Clear Processes for Reporting and Responding to Concerns

- We have clear procedures for identifying, reporting, and responding to child safety concerns.
- We meet mandatory reporting obligations and cooperate fully with relevant authorities.

7. Risk Management and Continuous Improvement

- We regularly assess and manage risks to child safety.
- Policies and practices are reviewed to ensure continuous improvement and compliance.
